1. THE LESSEE HEREBY ACKNOWLEDGES RECEIPT FROM THE LESSOR OF THE EQUIPMENT LISTED AND IDENTIFIED IN THIS CONTRACT AND THAT IT IS IN GOOD CONDITION.
 2. IT IS UNDERSTOOD AND AGREED THAT THE EQUIPMENT IS RENTED BY THE LESSOR TO THE LESSEE ONLY AND WILL BE USED BY THE LESSEE ONLY FOR THE STATED PERIOD AND SOLELY FOR THE PURPOSES FOR WHICH THE SAID EQUIPMENT WAS MANUFACTURED AND INTENDED.
 3. THE LESSEE AGREES TO INDEMNIFY THE LESSOR FROM ANY LIABILITY WHATSOEVER ARISING OUT OF THE USE OF THE SAID EQUIPMENT AND FURTHER AGREES THAT THE SAID PROPERTY WILL BE USED SOLELY BY THE LESSEE AND OR PERSONS HEREIN DESIGNATED AND NO OTHER PERSON UNLESS THE CONSENT OF THE LESSOR IS FIRST HAD AND OBTAINED.
 4. THE LESSEE SHALL IN THE EVENT THAT THE SAID EQUIPMENT SHOULD BECOME UNSAFE OR IN A STATE OF DISREPAIR IMMEDIATELY DISCONTINUE THE USE OF SAME AND SHALL NOTIFY THE LESSOR OF THE SAID DEFECTS AND THE LESSOR AGREES THAT IT WILL WITH REASONABLE DISPATCH AFTER RECEIVING SUCH NOTICE EITHER REPAIR OR REPLACE SUCH DEFECTIVE EQUIPMENT.
 5. THE LESSEE SHALL UPON THE TERMINATION OF THIS AGREEMENT IMMEDIATELY RETURN THE SAID EQUIPMENT IN THE SAME STATE AND CONDITION AS WHEN RECEIVED BY THE LESSEE, ORDINARY WEAR AND DEPRECIATION EXCEPTED AND THE LESSEE SHALL PAY FOR ANY DAMAGE TO THE EQUIPMENT OR FOR ANY LOST EQUIPMENT AND IN ADDITION SHALL PAY TO THE LESSOR ANY LOSS OF RENT WHICH MAY BE OCCASIONED TO THE LESSOR BY REASON OF THE LESSOR'S INABILITY TO REPAIR OR REPLACE SUCH EQUIPMENT WITHIN A REASONABLE TIME.
 6. ANY EXTENSION OF THE RENTAL PERIOD SET OUT HEREIN SHALL BE WITH THE CONSENT OF THE LESSOR AND SHALL BE SUBJECT TO THE TERMS AND CONDITIONS WHICH MAY BE THEN AGREED UPON.
 7. AT THE ELECTION OF THE LESSOR ALL RENTAL PAYMENTS SHALL BE -
 (A) IN ADVANCE
 (B) IMMEDIATELY UPON RETURN OF THE EQUIPMENT
 (C) UPON RECEIPT OF STATEMENT
 PROVIDED ALWAYS THAT ALL COSTS OF RECOVERING EQUIPMENT, INCLUDING COURT COSTS, LEGAL FEES, SHALL BE PAYABLE BY THE LESSEE.
 8. EQUIPMENT WHICH IS OVERDUE FOR A PERIOD IN EXCESS OF ONE WEEK SHALL BE CLASSIFIED AND DEEMED STOLEN PROPERTY.
 9. OVERDUE ACCOUNTS SHALL BEAR INTEREST AT THE RATE OF 1 1/4% PER MONTH (18% PER ANNUM)
 10. THE LESSEE AGREES THAT THE LESSOR MAY ENTER UPON THE LESSEE'S PREMISES FOR THE PURPOSE OF RECOVERING POSSESSION OF THE SAID EQUIPMENT AND NO ACTION SHALL BE MAINTAINED FOR TRESPASS OR OTHERWISE.
